Rules and Regulations from the Town of Talking Rock:

- 1. The Town of Talking Rock and the Talking Rock Farmers Market Committee and all persons, property owners, suppliers, volunteers, or entities connected with the Talking Rock Farmers Market are not liable for damages, injury or loss to any persons or goods from any cause whatsoever. All vendors, their heirs, administrators, and executors hereby waive and release all the above named from all claims or damages.
- 2. Farmers and agricultural products are given priority, and everything must be homegrown in Pickens County or a contiguous county.
- 3. Arts & Crafts products must be of high quality and hand crafted.
- 4. Vendors are responsible for setting up booths and providing their own supplies, i.e., tables, tents, chairs.
- 5. All vendors participating in the Talking Rock Farmer's Market shall comply with the sanitary rules and regulations of Pickens County and Georgia's Health Department. All food must be properly displayed, fresh, grown, prepared and packaged in accordance with all local, state and federal regulations.
- 6. Vendors are responsible for cleaning their assigned areas.
- 7. Vendors must have their booth(s) set up for the entire scheduled market (Sundays 12p 4p).
 - a. Sunday check-in begins at 11am. All vehicles must be detached and removed from the vendor space.
 - b. All vendor booths must be torn down, area cleaned and removed by 4:30p Sunday.
- 8. The Town of Talking Rock Farmers Market Committee will approve all vendors and planned attendance schedule.
- 9. Vendors' space will be assigned by the Committee (Special requests will be considered, but not guaranteed).
- 10. Vendors will make every effort to communicate any alteration or change in planned attendance prior to the scheduled market.
- 11. If applicable, there will be a \$50.00 charge for NSF checks.
- 12. The Talking Rock Events Team will establish a **GroupMe** Communication group dedicated to Farmers Market vendors that will allow for important vendor information to be disseminated efficiently and effectively. Please download the app at your earliest convenience. You understand that you will be added to this communication group and this will be the market's primary communication channel along with the Town of Talking Rock's social media pages.
